



2002 Year In Review State and Local Trans-Inclusive Legislation

In the year 2002, the number of people, according to the 2000 Census, who reside in a city, county or state that has explicit coverage for transgender people in its anti-discrimination law, rose by **18,472,684 people**, just barely **more than doubling** the number of people covered in the U.S. when 2002 began. The total number of people now living in a jurisdiction with a transgender-inclusive anti-discrimination law in the United States is **36.8 million people**, **13%** of the U.S. population.

Pennsylvania passed a Hate Crimes Law, which added gender identity among many other categories:

Passed Senate – June 21, 2001 – Vote 32-15
Passed House – November 26, 2002 – Vote 118-79
Signed by Governor Schweiker - December 3, 2002



2003 Year In Review State and Local Trans-Inclusive Legislation

In the year 2003, the number of people who reside in a city, county or state that has explicit coverage for transgender people in its anti-discrimination law, rose by **32,035,137 people**, nearly **doubling** the number of people covered in the U.S. when 2003 began. The total number of people now living in a jurisdiction with a transgender-inclusive anti-discrimination law in the United States is **68.8 million people**, **24.5%** of the U.S. population, at the beginning of 2003, it was 36.8 million people or 13% of the population. (Numbers according to 2000 Census)

STATEWIDE VICTORIES (4)

California amended the definition of sex to include protections for gender identity or expression in its employment and housing non-discrimination law:

Passed Assembly – April 21, 2003 – Vote 42-34
Passed Senate – July 24, 2003 – Vote 23-11
Signed by Governor Gray Davis – August 2, 2003

New Mexico added sexual orientation and gender identity to its non-discrimination law covering housing, employment and public accommodations:

Passed Senate – February 26, 2003 – Vote 22-18
Passed House – March 21, 2003 – Vote 32-26
Signed by Governor Bill Richardson – April 8, 2003

New Mexico passed a hate crime law that included gender identity or expression among many other categories:

Passed Senate – February 7, 2003 – Vote 24-17
Passed House – March 20, 2003 – Vote 39-27
Signed by Governor Bill Richardson – April 8, 2003

Hawai`i amended its hate crime law to include crimes motivated by gender identity or expression:

Passed Senate – March 4, 2003 – Vote 22-3
Passed House – March 31, 2003 – Vote 39 - 8 (4 excused)
Became law without Governor Linda Lingle's Signature – April 22, 2003



2004 Year In Review State and Local Trans-Inclusive Legislation

In the year 2004, the number of people, according to the 2000 Census, who reside in a city, county or state that has explicit coverage for transgender people in its anti-discrimination law, rose by **1,067,918 people**. The total number of people now living in a jurisdiction with a transgender-inclusive anti-discrimination law in the United States is **69 million people, 25%** of the U.S. population.

The local jurisdictions that added protection for transgender people, either alone or simultaneously with sexual orientation:

Oakland, CA – January 7, 2004 – Vote 7-0
Tompkins County, NY – February 17, 2004 – Vote 11-4
Albany, NY – April 7, 2004 – Vote 13-1
Austin, TX – June 10, 2004 – Vote 7-0
Bend, OR – June 16 – Vote 7-0
Miami Beach, FL – July 7, 2004 – Vote 7-0
Burien, WA – November 1, 2004 – Vote 6-0
Beaverton, OR – November 15, 2004 – Vote 5-0

Note: On December 9, 2004, the Louisville Metro Council re-passed Louisville/Jefferson County's anti-discrimination law, an action needed to preserve the law after the City of Louisville and Jefferson County merged on January 6, 2003. The vote was 19-6.

Vote Totals for Local Jurisdictions: 82 yes votes and 11 no votes, with six of the nine jurisdictions passing their laws unanimously.

STATEWIDE VICTORY

Connecticut added “gender identity and expression” to the state hate crimes law:
Passed House of Representatives – April 22, 2004– Vote 139-4
Passed Senate – April 29, 2004 – Vote 33-0
Signed by Governor Rowland – May 21, 2004



2005 Year in Review State and Local Trans-Inclusive Legislation

In the year 2005, the number of people who reside in a city, county or state that has explicit coverage for transgender people in its anti-discrimination law, rose by **10,474,538 people**. The total number of people now living in a jurisdiction with a transgender-inclusive anti-discrimination law in the United States is **80.4 million people, 29%** of the U.S. population. (Data according to 2000 Census)

Illinois amended its non-discrimination law to include LGBT protections:

Maryland amended its state hate crimes law to include LGBT protections:

Signed by Governor Robert Ehrlich – May 26, 2005

Colorado amended its hate crimes law to include LGBT protections, as part of the omnibus law enforcement bill:

Passed House – April, 7 2005 (no vote on the omnibus package)
Passed Senate – April 27, 2005 (no vote on the omnibus package)
Passed without Governor Bill Owens' signature – May 27, 2005

Hawai'i amended its housing non-discrimination law to include LGBT protections:

Passed Senate – April 4, 2005 – Vote 20-5
Passed House – April 21, 2005 – Vote 44-7
Signed by Governor Linda Lingle – July 12, 2005

California amended its insurance code to prohibit discrimination against trans people:

Passed Assembly – September 7, 2005 – Vote 45-34
Passed Senate – September 6, 2005 – Vote 23-14
Signed by Governor Schwarzenegger – September 29, 2005

California clarified that discrimination by public accommodations against LGBT people is prohibited:

Passed Assembly – August 29, 2005 – Vote 48-29
Passed Senate – August 22, 2005 – Vote 22-16
Signed by Governor Schwarzenegger – September 29, 2005

2006 Year in Review State and Local Trans-Inclusive Legislation

In the year 2006, the number of people who reside in a city, county or state that has explicit coverage for transgender people in its anti-discrimination law, rose by **14,172,038 people**. The total number of people now living in a jurisdiction with a transgender-inclusive anti-discrimination law in the United States is **94 million people, 34%** of the U.S. population. (Data according to 2000 Census)

Washington state amended its non-discrimination law to include LGBT protections:

Signed by Governor Christine Gregoire – January 31, 2006

Hawai`i enacted a law prohibiting discrimination against LGBT people in public accommodations:

Passed House – March 7, 2006

Passed Senate – April 3, 2006 – Vote 18-4 (3 excused)

Became law without the signature of Governor Linda Lingle – May 2, 2006

New Jersey enacted a law prohibiting discrimination based on gender identity or expression:

Passed Senate – December 11, 2006 – Vote 31-5, December 14, 2006 Vote – 33-3

Passed Assembly – December 14, 2006 – Vote 69-5 (6 abstentions)

Signed by Governor John Corzine on December 19, 2006

In 2007, the number of people who reside in a city, county or state that has explicit coverage for transgender people in its anti-discrimination law, rose by **12 million people**. The total number of people now living in a jurisdiction with a transgender-inclusive anti-discrimination law in the United States is **107 million, 38%** of the U.S. population. (Data according to 2000 Census)

Signed by Governor Chet Culver on May 25, 2007

Vermont passed a law prohibiting discrimination against transgender people:

Passed House – Vote 118-28 – May 2, 2007
Passed Senate – Vote 27-1 – March 16, 2007
Signed by Governor Jim Douglas on May 22, 2007

Colorado enacted a law prohibiting discrimination against LGBT people:

Passed Senate – Vote 20-15 – April 17, 2007
Signed by Governor Bill Ritter on May 25, 2007

As of July 2008, the number of people who reside in a city, county or state that has explicit coverage for transgender people in its anti-discrimination law, rose by **2 million people**. The total number of people now living in a jurisdiction with a transgender-inclusive anti-discrimination law in the United States is **109 million, 39%** of the U.S. population. (Data according to 2000 Census)
